In addition, provide Musical Instruments and Live Entertainment to VA Facilities nationwide.

The Musical Instrument Loan Program provided Musical Instruments and training materials to 103 at risk and disadvantaged youth. In addition, Charity Music provided Musical Instruments and materials to homeless students. Charity Music's Instruments Petting Zoo participated in over 35 Festivals, allowing over 4500 children enjoyed their first experience in playing a musical instrument.

The Charity Music Library provides Sheet Music, Music Books, and various training aides at no charge to individuals wishing to improve their musical talents. The Library currently contains over 3500 items. Planning efforts continued for a 15,000 square foot facility to be constructed on 4.7 acres of donated land in Sterling Heights Michigan. The Musical Instrument Repair and Training Center will contain the Music Library, Vintage Musical Instrument Exhibit, Community Recording Studio, and several class rooms.

Continued operation of the Charity Music Volunteer and Creative Arts Center in Clinton Township, Mi. Expanded the Charity Music Volunteer Program and provided tasks for over 250 volunteers. Volunteer opportunities are currently available for Students, Seniors, and Court Mandated Community Service volunteers. Continued efforts to establish Charity Music College Campus Liaisons throughout the nation. As a certifying organization for the President's Volunteer Service Award program, Charity Music assisted in providing awards to 18 volunteers. Continued our Fiscal Sponsorship program to provide support for various worthy causes with compatible missions. Provided Court Mandated Community Service opportunities to 61 new clients.
